YOUNG FILMMAKERS WORKSHOP

AFTRS is the Australian Government's national centre for professional education and advanced training in film, television and radio for talented Australians. Its graduates are a who's who of the industry and include Oscar, Cannes and international award winners.

For the first time ever AFTRS Adelaide will open its doors to creative and talented young people between the ages of 13 – 15, to participate in this exciting workshop from 14 –16 April 2010.

Participants will be guided by industry professionals to make a short film. Students will be exposed to a range of film making styles and techniques and learn how to create stories by combining moving images, voice, sound effects and music. Students will work as part of a creative team to produce their short film.

Workshop Outline

Day 1

Participants will be divided into groups to develop a script for a 2-3 minute short film, they will also develop storyboards, a shooting schedule, props list and location survey – ready to shoot the film the following day. Groups must have all scripts on paper and locations ready for next day's shoot.

Day 2

Camera and sound recording skills. The groups will take part in a practical shooting and shoot their film under supervision. The aim is for all students to have a turn using the camera and feel confident with their shots.

Afternoon Session

Introduction to editing using Mac computers, the tutor will explain the process while capturing the day's footage for the students.

Day 3

The tutor will further demonstrate editing techniques. Students will then be divided into pairs to edit their own version of their group's film.

Late afternoon

The groups will watch the finished films in a group screening and DVD copies will be made for participants to take home.
